#### Official Course Description

Examination of current environmental issues related to physical geography, including topics such as climate change, energy and sustainable resource development, weather extremes, and natural hazards. The course uses contemporary topics to introduce fundamental principles of physical and environmental geography while highlighting societal impacts and influences.

#### Course Objectives

This course is intended to provide an overview of how humans have changed the Earth's physical environment, including the atmosphere, ecosystems, water and physical landscapes. Given that the global environment is ever changing, the course will include discussions of how the Earth's systems have changed in the past due to natural factors.
