#### **Official Course Description**

Introduces mapping technologies and digital spatial data for solving geographical problems that focus on how to collect, manage, analyze, and communicate diverse spatial data. Topics include geographic information systems (GIS), remote sensing, spatial statistics, geovisualization, cartography, and web mapping.

#### **Course Objectives**

The goal of this course is to introduce the wide array of digital mapping and geospatial tools and technologies used in geography and other fields, which increasingly underpin contemporary digital society. Together, we will examine the use of geospatial data and technologies in everyday life. Some key application areas will include recreation, disaster management, precision agriculture, climate change and more. Topics will be explored to both to help our thinking about how the tools of digital mapping represent the world, consider the message and ethics of those representations, and data ownership.

### **Course Format**

Until November 7, every Tuesday will be synchronous and every Thursday will be asynchronous. After November 7, all lectures will be asynchronous. *Asynchronous* means that you will be expected to watch the online lecture video on your own time; you may, of course, use the regularly scheduled time T/Th 9:30-10:45 to do so. Put simply, the synchronous dates are: Sept 7, 14, 21, 28; Oct 5, 12, 26; and Nov 2.

You will be expected to complete all course assignments except for the in-class engagement exercises outside of scheduled class time. All tests will be considered synchronous.

### **Policy on Late Assignments**

Most deliverables will be submitted through D2L and, as a result, will be automatically time stamped. A deliverable is considered late if the time stamp is later than the published due date/time indicated. Deliverables received within 1 minute to 24 hours of the due date will be assessed a 10% penalty. This means if your assignment receives a grade of 78% it will be entered as 68% (78 - 10= 68) on the grade sheet. If it is received between 24 and 48 hours, it will be assessed a 20% penalty. If the assignment is received greater than 48 hours from the due date it will be assessed a penalty of 30%, and so forth.

Zoom is a video conferencing program that will allow us to meet at specific times for a "live" video conference, so that we can have the opportunity to meet each other virtually and discuss relevant course topics as a learning community.

Zoom links and passwords are only intended for students registered in the course. Zoom recordings and materials presented in Zoom, including any teaching materials, must not be shared, distributed or published with the instructor's permission.

Students will be advised before the instructor initiates a recording of a Zoom session. These recordings will be used to support student learning only and will not be shared or used for any other purpose.
