## **Official Course Description**

Exploration of what it means to be Canadian in a global context. Examination of the historic, cultural, social, political, economic, and environmental factors that promote unity and inter-regional tensions.

#### **Course Objectives**

The primary objective of this course is to explore what is means to be Canadian. We will explore Canada from a spatial-historical perspective which implies that space is not just an empty vessel to be filled with history, but that space is itself historical, shaped by economic, political, social, cultural, and environmental factors. Interregional similarities and differences will be highlighted, focusing on the factors that promote Canadian unity and disunity. Factors that led to rapid urbanization and its effects will be discussed. The course will consist of online recorded lectures, videos, readings, and a project.

### **Prerequisites**

No prerequisites required. There are no prerequisite skills for this course. All students should have access to a computer with a microphone and video (recommended). A stable internet connection is important as all the components are delivered on the internet (see learning requirements section following).

### **Course Format**

The course is offered as an asynchronous course. Recorded lectures, films, readings are provided for each module. A detailed course schedule is posted outlining the course material for each week and the quiz schedule. There is one synchronous session to select groups for the term assignment. This can also be arranged asynchronously by communicating with the Instructor your choice of topic if you are unable to attend this session. Lecture topic 00 posted online explains in detail the course format, the course outline, and the course components.
