An introduction to fundamentals in cartography, remote sensing, geographic information systems and descriptive spatial statistics.

Course Objectives

Geog 380 provides the theoretical knowledge, technical skills, and practical experience necessary to pursue advanced courses in *geospatial technologies*: cartography, GIS, remote sensing, and statistics.
