**Course Description**

Exploration of the underlying theories and procedures of qualitative research in human geography. Overview of methodologies including conventional approaches (case studies, ethnographies, grounded theory) and critical avenues such as feminist and indigenous approaches. Advanced discussion and application of qualitative methods (interviews, discourse analysis, observation, action-oriented research, literature reviews).
